Dear Parent(s)/Guardian(s):

Trinity's Homecoming Dance is scheduled for Friday, September 30, 2016 and will be held in the Sr. Michelle Germanson Athletic Facility from 7:00 p.m. to 10:00 p.m. All students are expected to arrive no later than 7:30 and will remain at the dance until 9:30. All students who are attending the dance must be present at and complete the Walk-a-thon the morning of September 30th. Upon completion of the Walk-a-thon, students wishing to attend the Homecoming Dance MUST return to school on the bus provided by Trinity. Once a student has returned to Trinity on the bus, she is dismissed from school for the day.


Each student is allowed to bring one (1) guest and must have a completed permission form turned in to Mrs. Bedell by noon on September 28th in order to attend the dance. Attire for the evening is semi-formal; all dresses must be Catholic School appropriate (no high cut slits, no low cut necklines, no short skirts etc.) Male guests should wear a collared shirt or turtle neck and dress slacks (No jeans will be permitted.) Trinity students and their guests must present their high school I.D. at the door.

We wish to be very clear about the consequences of alcohol or drugs at school events. The distribution, use or evidence of drugs, marijuana or alcohol at Trinity High School or any school-sponsored function by students and/or their guests is absolutely forbidden. Any violation will result in strong disciplinary action, including possible dismissal from school. Should your daughter's behavior indicate any consumption of drugs or alcohol, you will be called to take your daughter and her date home. Your daughter will be suspended from school until a meeting can be arranged between you, your daughter and the Administration. Should your daughter's guest indicate that he/she has consumed alcohol or drugs, the police will be notified and you will be called.

In addition, we do not condone or endorse pre or post-dance parties at hotels or private homes, especially where alcohol may be served. The dance is supervised by school personnel from 7:00 p.m. to 10:00 p.m. Please be aware of your daughter's plans for the evening. We encourage you to take advantage of the opportunity before the dance to engage in a serious conversation with your daughter about these important matters.

All detentions must be served before dance tickets are sold and any student attends the dance. We know you understand that school policies are made with the best interests of your daughter in mind. We ask that you sign the form below indicating your support of and cooperation with this policy. This form must be returned when your daughter buys a ticket for herself and her guest. The cost of the dance is \$40.00 per couple or \$20.00 for an individual. Tickets will be sold through 3B on September 30, 2015.
